





Cumulative Impacts Act

Mandates that environmental impact statements address effects on environmental justice communities, and that environmental impact statements for power plants demonstrate alignment with the CLCPA. (A2103, Pretlow; S1031b, Stewart-Cousins)

Climate and Community Investment Act

Creates a new authority funded by a polluter penalty fee paid by corporate polluters to fund:

- 1. large scale investments like offshore wind, electric buses, and public housing energy upgrades;
- 2. grants to community organizations to create local climate, adaptation, and resiliency projects, particularly in frontline communities;
- 3. support for fossil fuel dependent workers and communities; and 4) rebates for working New Yorkers and small businesses to defray increased energy costs. (A6967, Cahill; S4264, Parker)

New York Build Public Renewables Act

Enables the New York Power Authority (NYPA) to build affordable renewable energy to meet our climate targets and to retrofit public buildings with weatherization measures, electric heat pumps, and toxic remediation by 2030. This will create between 28,000 and 51,000 jobs, with NYPA requiring prevailing wage on all projects. (A1466, Carroll; S6453, Parker)






