## **CERTIFICATE OF LIABILITY INSURANCE**

All renters must provide a certificate of insurance for the date of their event. If your event includes the services of a caterer, professional deejay, or other vendor they, too, must provide certificates of insurance. Repeat renters can get a certificate for a whole year.

Ask your insurer to provide a certificate of insurance, naming the **First Unitarian Universalist Society of Albany** 

as additional insured to the value of \$1 million.

If you do not have a current insurer who can provide this coverage, you can obtain single event coverage at: <a href="https://www.theeventhelper.com">www.theeventhelper.com</a>, (855) 493-8368. They can also provide annual policies for recurring meetings.
